# **Giving tax-efficiently**

Gift aid is a bonus to any money you give to a chariy. Regular tax effective giving enables us to play a part in our community and in worldwide mission. Under government regulations all money given to a charity may benefit from a refund of tax that you might have already paid on your donation. If you are a taxpayer (paying sufficient income tax or capital gains tax to cover the amount to be recovered on your giving) please complete a Gift Aid form (available in church)

A single declaration will cover all your current and future gifts, both standing order and oneoff gifts, and may be cancelled at any time. You will need to ensure that the total tax reclaimed on your gifts to charities in any one year does not exceed the amount of income tax or capital gains tax you pay in the same year.



# **A Biblical Perspective**

## ' Thanks be to God for His inexpressible gift!' 2 Corinthians 9: 15

This verse sums up the main motivation for Christian giving: thankfulness. We want to express our thanks to God for our salvation in Jesus and acknowledge that everything we have comes from him.

In a culture dominated by materialism and individualism, there is something distinctively radical about Christian giving. When Christians make sacrifices in order to benefit others they are living contrary to the spirit of our age. But why do we do this? King David observes in 1 Chronicles 29 that everything belongs to God. Therefore all our resources should be at God's disposal and used in His service; giving financially is one expression of this. 2 Corinthians 8 & 9 says Christian giving should be:

- **Motivated by Grace** (8:1-9) Christian giving is a response to the Gospel of Grace.
- In proportion to our means (8: 12-15) We give according to the riches God has given us.
- Willing and cheerful (9: 1-7) God loves a cheerful giver who gives gratefully in response to God.
- A source of spiritual blessing (9: 8-11) God promises that grace will abound as we give ourselves and resources generously in His service.
- A source of thanksgiving to God (9: 12-14) Christian giving is a huge source of encouragement to those who receive it.

## How you can give

## **Cheques And Cash**

We do not take up a collection during the service at St Thomas', but gifts can be placed in the box or plate at the entrance to the church or posted to the church office. Cheques should be made payable to St Thomas' Church.

### Standing order

If you like to give regularly, please consider setting up a bank payment —the easiest way to dothis up is online - bank details are St Thomas Trowbridge, Sort code: 40 44 33 a/c no: 21223194

**Gift Aid** — the government's gift to charities, whereby we can reclaim income tax paid on donations - please see overleaf for more details.

## **Gift Aid Small Donation Scheme (GASDS):** this scheme was introduced to complement the Gift Aid scheme - on any gift up to £20 (£30 from April 2019) given to us where we can't identify the donor (ie it

isn't a cheque or marked in any way with the donor's name) we can reclaim the income tax that may have been paid on it.

Gift Aid and GASDS combined mean that we can reclaim £20,000+ each year
